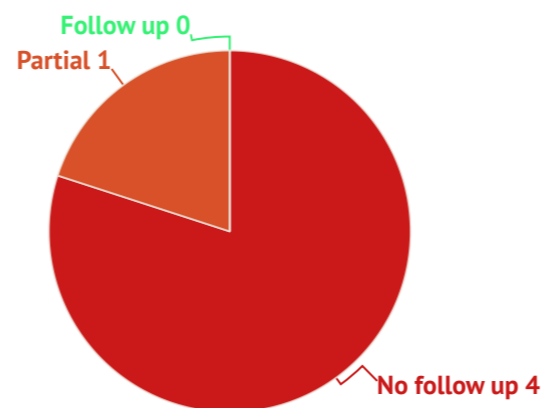

## General Review: Sub inspection III (KPSM)

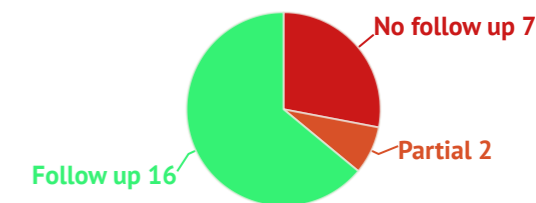

- Bottlenecks in the areas of updating the legal framework, regulating legal status, earmarking sufficient funds in budgets and a financial mandate for the head of the service.

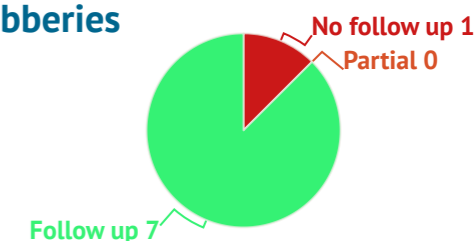

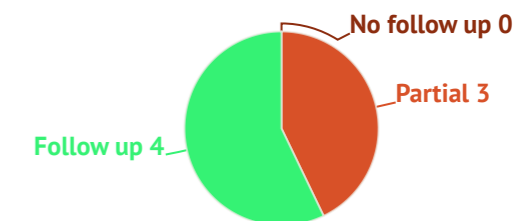
